Biden Administration Withdraws Covid Vaccine Mandate:

The Biden administration is formally withdrawing its vaccine and testing mandate for businesses, after the Supreme Court blocked the requirements earlier this month in a 6-3 decision, ruling that the Occupational Safety and Health Administration had exceeded its authority. OSHA will pull the rule for businesses effective January 26, the agency said in a statement posted to its website.


Truitt Radio:

Alabama Damage Prevention Alliance (ADPA) - Large Project Committee:

The ADPA Large Project Committee held a virtual meeting on January 26th to resume discussions for developing a draft for a Large Project Process in Alabama.



- Define elements of a project relative to a linear large project and a site-specific large project.
- Establish a project locate requests option within Alabama 811 locate request options.
- A project locate request will establish a meeting time to review the planned project activity it will not require physical marking. Should include the physical description that would cover the proposed project for the purpose of determining which members to be notified.
- A project locate request would have a minimum of a five working day notice, which is already allowable within the law.
- Facility owners will respond to the project request using the positive response codes. Options will
 be available to agree to meeting, unable to meet but responsible for obtaining information from
 excavator prior to meeting date, note that site is clear, note that no facilities in the area of the
 scope of work, or facility owner will mark their area within the 5 day notice.
- Positive response codes will have to be updated within the Alabama 811 system.
- At the project meeting an agreed upon marking schedule will be established and agreed upon by all those in attendance.
- All known sub-contractors will be noted on the working agreement
- Once an agreement has been finalized, locate requests will be placed within the normal 2-10 working day notice as outlined in the marking schedule.
- Any changes to the marking plan agreement must be agreed to by all parties involved.





Alabama Underground Damage Prevention Authority (ALUDPA)

The Alabama Underground Damage Prevention Authority (ALUDPA) was established for the purpose of enforcing the Alabama Underground Damage Prevention State Law, for reviewing penalty provisions, and for reviewing the adequacy of the Alabama State Law Enforcement Program.

The Enforcement Program is a complaint-driven process where a complaint may be submitted against an entity for violation of the Alabama Underground Damage Prevention State Law. A complaint may be submitted as information only and not designated for enforcement penalties.



A complaint may be submitted using the Complaint Form <u>at this Website</u> no later than 30 days after the occurrence of an alleged violation. The submitted Complaint Form is reviewed by the ALUDPA for determination of an alleged violation and for penalty provisions that may apply. The reported violator is then notified by the ALUDPA that a response may be submitted using the Response Form at this Website no later than 14 days after the ALUDPA notification.

OSHA:

On January 5th, OSHA issued a <u>press release</u> to remind employers that the agency began collecting calendar year 2021 Form 300A data on Jan. 2, 2022. Employers must submit the form electronically by March 2, 2022. Electronic submissions are required by establishments with 250 or more employees currently required to keep OSHA injury and illness records, and establishments with 20-249 employees classified in specific industries with historically high rates of occupational injuries and illnesses. Alabama Legislative News:

The 2022 Alabama Legislative Session convened in Montgomery at noon on Tuesday, January 11th. Governor Kay Ivey delivered her State of the State address that evening to a limited audience in the State Capitol. During the first week of the session, legislators met for 2 legislative meeting days.

Legislators reconvened the following week in Montgomery for the 3rd legislative day. However, as expected, Governor Kay Ivey called for special session solely to address how the state will use the \$772 million in federal pandemic relief funds from the American Rescue Plan Act (ARPA), passed by Congress in March 2021. The special session began on the morning of Wednesday, January 19th. This put the regular legislative session on hold until at least February 1st.

On the 1st day of the special session, identical bills were introduced in the House and Senate that would provide a total of \$277 million towards expanding broadband, with \$85 million available immediately and another \$192 million funded through capital projects. Water and sewer improvements would make up \$225 million of the appropriations with up to \$120 million designated for high-priority or emergency projects previously identified under the Clean Water State Revolving Fund or the Drinking Water State Revolving Fund. Another \$100 million is set out for matching grants for water or sewer infrastructure projects. As a result, our industry should see a quick influx of new infrastructure project opportunities. All of these projects funded with the ARPA money have to be finished by the end of 2026. With ongoing supply chain issues, material price volatility, and an extremely limited workforce, this will create its own set of challenges.

The special session concluded on Thursday, January 27th, after Alabama lawmakers gave final approval to a plan to use \$772 million in federal pandemic relief funds. The bill has now been sent to Governor Kay Ivey for her signature. The bill calls for \$277 million to go toward expanding broadband; \$225 million toward water and sewer improvements; and \$146.7 million, toward health care, to be split between hospitals and nursing homes. It also include \$79.5 million for the state's Unemployment Compensation Trust Fund, and \$11 million to reimburse the counties for the cost of housing state prisoners.

The regular session is expected to resume on Tuesday, February 1, on what will be the 4th legislative meeting day. To date, there have been a total of 174 bills introduced in the House, and 120 in the Senate. Since it is an election year, many are anticipating the regular session adjourning early to allow candidates time to campaign ahead of the May 24th primary elections.

Clean Water Construction Coalition Report

"Build Back Better Act" Stalls In Senate – Congress in Recess

As previously reported, in late November the House passed the \$1.9T Build Back Better (BBB) bill in partisan fashion. It was not acted on in the Senate by the end of the year and Congress is now in recess.

On Dec. 16, the Senate Environment and Public Works Committee released its title to the Senate's version (whatever that becomes) of the BBB. In addition to the authorized funding from the Bipartisan Infrastructure Framework (BIF), this measure includes \$9B for SDWSRF-funded lead remediation projects, \$225M for rural and low-income water assistance grants, \$125M for Alternative Water Source Program grants, and \$500M for sewer overflow and storm water reuse municipal grants.

Highlights of the Senate Finance proposed tax title are enclosed in the attached report from Key Advocates. Although not "infrastructure" in nature, these proposed tax provisions may be of interest to your members from a corporate perspective.

Bipartisan Infrastructure Framework: Summary of 2022 Environmental Protection Agency State Revolving Funds (SRFs) by States, Tribes, and Territories

We reported last month that EPA Administrator Regan issued notice (here) to all states laying the groundwork for next steps with BIF funding for specific programs. National program guidance from the EPA's Office of Water to state primacy agencies for the use of water infrastructure funding through the BIF is pending. We await this guidance and will report once available.

Included in this letter are estimated 2022 state allotments of BIF funds through the SRFs — significant resources that we know will go a long way toward achieving our shared goals. The enclosure summarizes the first-year allotment of nearly \$44 billion in total SRF funding that will be provided to states, tribes, and territories over the next five years through the BIF.

We recommend you review these estimates and begin engaging your partners in state government NOW to ensure that this funding is distributed in an efficient manner on behalf of your organizations. Capacity challenges to get this money spent are to be expected and can be mitigated with proactive engagement.

2022 Price Increase Prediction Commercial Auto Insurance Overall: +10% to +25%

According to a recent report from AM Best, *commercial auto underwriters saw more than \$22 billion in underwriting losses between 2011 and 2020*. This is despite underwriters increasing commercial auto premium pricing for 41 consecutive quarters, dating back to Q3 of 2011. Insurance carriers have not returned an underwriting profit for commercial auto lines in over a decade.

Industry experts predict that this hard market will continue to be a concern in 2022 and beyond. The majority of businesses with commercial auto exposures—regardless of their industry or vehicle class—will have a more difficult renewal process by way of –

- greater premium rates,
- lowered capacity and
- more stringent policy requirements or restrictions.
- Further, insureds with larger fleets or a poor loss history may experience more significant rate increases.

Developments and Trends to Watch

Nuclear verdicts - These are jury awards in which the penalties exceed \$10 million—have become increasingly prevalent. **These large losses accounted for 35% of all trucking losses over \$1 million from 2017 to 2021.**

Distracted driving issues - (NHTSA) indicates that, every year, up to 391,000 people are injured, and 3,450 people are killed in crashes involving distracted drivers. As a whole, distracted driving incidents account for nearly 10% of all fatal crashes on the road.

Marijuana legalization exposures—*NHTSA data found that cannabinoid use among fatally injured drivers has more than doubled over the last decade*. While all states have some form of legislation in place regarding marijuana-impaired driving, many enforcement limitations still exist due to minimal drug-detecting technology and the lack of a widely recognized impairment limit.

Crash severity concerns—Even though fewer drivers were on the road in 2020, the NHTSA reported that an estimated 38,680 individuals were killed in motor vehicle crashes throughout the year—representing a 7.2% increase from the previous year and the highest annual death toll since 2007. In the first six months of 2021, the country's fatal crash rate continued to climb—rising by an additional 3%.

Repair cost obstacles—Modern vehicle features including blind-spot cameras, backup alarms, GPS devices and telematics software repairs comes with a hefty price tag. In fact, according to a re-

cent report from AAA, vehicles equipped with driver assistance systems often cost twice as much to repair as those that aren't.

You almost never win a court case once you get into court. (Been there done that!)
